General Rules

- 1. It shall be the responsibility of all members to have knowledge of any and all range rules and abide by all range rules.
- 2. Members will cease fire and leave the range if told to do so by any range or executive officer for violation of the rules and regulations.
- 3. Violations of range safety rules could be grounds for revocation of club membership if determined by the management.
- 4. Alcoholic beverages are not permitted on firing range at anytime.
- 6. Parking of vehicles shall be in a safe designated area.
- 7. Applicants must complete the appropriate application form approved by the management.
- 8. Applicants are to present a valid NJ Firearms Identification Card and a government issued photo ID where applicable. NRA membership is strongly encouraged, but not required.
- 9. No person will be considered for membership who has a physical or mental disorder which would be considered unsafe for the handling of firearms, in the opinion of the membership committee.
- 10. It is every member's responsibility to keep the range property clean.
- 11. All members must sign in at the club house immediately upon arrival before they can shoot.
- 12. Guest(s) are permitted to shoot and handle firearms on the range if accompanied by a club member. In addition, prior to shooting, guest(s) must fill out and sign the application safety rules and regulations. Guest(s) must conform to our guest policy.
- 13. After shooting, all score cards must be submitted to the club house attendant.
- 14. All shooting cost must be paid the same day, such as the # of shooting rounds and guest fees.
- 15. If accepted as members, applicants agree to maintain a current mailing address and a working telephone number on file with the club.
- 16. Members may not loan their membership cards to anyone.
- 17. No pets allowed at the range facility.
- 18. The range is a first come, first serve basis.
- 19. There may be a short waiting time when the range is operating at full capacity

Firearms and Ammunition Restrictions

- 1. The use and possession of rifles on the range is limited to target and sporting types only.
- 2. No fully automatic firearms (machine guns) are permitted.
- 3. Any gun which cannot be fired from the shoulder or held at arms lengths is prohibited.
- 4. The use of tracer, incendiary or armor-piercing ammunition is prohibited.
- 5. Specific types of firearms and ammunition allowed on each range are defined in the rules for the range.

Range Safety Rules

- 1. All firearms must be unloaded and made safe except while on the firing line. This rule includes holstered guns.
- 2. Organized shooting events will be conducted under the supervision of a formally designated range officer.
- 3. Keep the muzzles of all firearms on the firing line pointed down range.
- 4. Keep the muzzles of all firearms pointed in a safe direction at all times off the firing line.
- 5. Loaded firearms shall not be elevated above the top of the backstop and any loaded firearm, or one containing live ammunition, shall not be left unattended.
- 6. Only safe firearms and ammunition are permitted.
- 7. Incendiary, tracer or explosive bullets, or fireworks, flares and other explosive devices are not permitted.
- 8. All shooters will cease fire upon command and unload all firearms immediately.
- 9. Anyone observing an unsafe condition on the firing line is obliged to give the "Cease Fire" command immediately.
- 10. Firearms not in use will have actions open, slides back or be in a gun case.
- 11. No firearm will be handled when anyone is down range.
- 12. Firearms are to be loaded on the firing line only.
- 13. Treat every firearm as if it were loaded at all times. In general: Never aim a firearm unless you intend to shoot. Never shoot a firearm unless you can hit the target.
- 14. Be familiar with your firearm and its proper ammunition. Read the instruction manual or ask if you are not sure.
- 15. Eye protection is required and ear protection is strongly recommended for shooters and observers.
- 16. No rifles or pistols are to be used on the trap field.
- 17. All shooting is to be done toward the present impact area.
- 18. No shot larger than #7 $\frac{1}{2}$ will be used on the trap or skeet ranges.
- 19. No hulls are to be picked up during a skeet or trap round.
- 20. Spent hulls and other trash are to be removed from the range when shooting is finished.
- 21. Unfired ammunition is not to be left on club property.
- 22. Flatten and place all empty cardboard boxes in the cardboard-only dumpster next to the club house.
- 23. You must not load with more rounds than the number of targets that are being fired.
- 24. Damage to club property or unsafe use of guns is never permitted. Members must correct and observe unsafe situations and must report damage/unsafe conditions to the appropriate chairman.
- 25. Action of gun is to remain open while at the facility except when it is your turn to shoot.
- 26. Gun MUST NOT be loaded until you are in a shooting position.
- 27. Always control your muzzle. Point your gun down range during loading, unloading, or when making adjustments or repairs.

- 28. Load no more than 2 shells at skeet stations 1 through 7 or trap doubles. Load no more than 1 shell at skeet station 8 or trap singles.
- 29. When a shell does not fire, wait 3 full seconds. Before you open gun, walk with the gun closed and muzzle "safe & pointed in air" to an area away from people, open gun and dispose of dud away from people.
- 30. Clean up after yourself.
- 31. Do not walk in front of the low house or the trap house while the release mechanism is in the hands of the puller.
- 32. No intoxication beverage is permitted on or in the vicinity of the range at any time.
- 33. No one is permitted in skeet or trap houses without permission of the Range Master or shoot management
- 34. No ammunition heavier than 3 drams of powder and number 7 ½ shot is permitted.
- 35. Event chairman controls the range during club-sanctioned events. The chairman will try to accommodate casual member use of range during events when possible.
- 36. All club members are responsible for reporting an infraction of these rules to management.
- 37. In all instances not covered by established safety rules, the decision and direction of the Range Master or shoot management will be final.

Guest Policy

- 1. Guests are permitted to shoot and handle firearms on the range if accompanied and supervised by a club member.
- 2. Club member is responsible for the guests' actions
- 3. Guests must fill out and sign the application and the range safety rules.
- 4. Guests must conform to all the general rules and range safety rules of the club.
- 5. All dues must be paid the same day. Dues such as the # of shooting rounds and guest fees.
